We hereby understand and agree that the exhibit space(s) leased herewith consists of the specified divider drapes. The minimum dimension of a single booth is 8' x 10', with a backdrop drape of 8 feet and side divider drapes of 3 feet. **(1) 6' table, (2) chairs and a trashcan will be provided during the show at no additional cost.**

2. Water, gas, electricity, & internet are exhibitor responsibilities in accordance with Gaylord Rockies Resort & Convention Center.
3. **As a condition of Neighborly Reunion registration, each vendor will be asked to donate item(s) in the amount of \$100 to be given away during Neighborly Reunion events.**
4. All booths must be manned at all times during the show hours. Failure to be manned during scheduled hours may result in disallowed future Reunion participation.

HOWEVER, IT IS EXPRESSLY UNDERSTOOD AND AGREED BY EACH AND EVERY CONTRACTING EXHIBITOR AND ITS AGENTS THAT NEITHER NEIGHBORLY, PAST, PRESENT, AND FUTURE ADMINISTRATORS, AFFILIATES, AGENTS, ASSIGNS, ASSOCIATES, ATTORNEYS, BENEFICIARIES, DIRECTORS, EMPLOYEES, ESTATES, EXECUTORS, HEIRS, INSURERS, LEGAL REPRESENTATIVES, MEMBERS, OFFICERS, PARENTS, PARTNERS, PREDECESSORS IN INTEREST, PROFESSIONAL ASSOCIATIONS, REPRESENTATIVES, SELF-INSURANCE PLANS, SERVANTS, SHAREHOLDERS, STAFF, SUBSIDIARIES, SUCCESSORS IN INTEREST, TRUSTS, TRUSTEES, AND ALL OTHER PERSONS, FIRMS, CORPORATIONS, ASSOCIATIONS, AND OTHER ENTITIES WITH WHOM ANY OF THE FORMER HAVE BEEN, ARE NOW, OR MAY HEREAFTER BE AFFILIATED, NOR ITS CONTRACTORS SHALL BE LIABLE FOR LOSS OR DAMAGE TO THE GOODS OR PROPERTIES OF EXHIBITORS. AT ALL TIMES SUCH GOODS AND PROPERTIES REMAIN THE SOLE POSSESSION AND CUSTODY OF EACH EXHIBITOR. THE EXHIBITOR AGREES TO DEFEND AND INDEMNIFY NEIGHBORLY, IT'S MANAGERS, OFFICERS, MEMBERS, SPONSORS, EMPLOYEES, AND AGENTS AND TO HOLD THEM HARMLESS FROM ALL CLAIMS, DEMANDS, ACTIONS, COMPLAINTS, SUITS OR LIABILITY FOR ANY PROPERTY DAMAGE, PERSONAL INJURY OR OTHER DAMAGES THAT MAY BE SUSTAINED BY ANY INDIVIDUAL OR ENTITY, INCLUDING THE EXHIBITOR AND HIS AGENTS OR EMPLOYEES, ON OR ABOUT THE EXHIBITOR'S DISPLAY SPACE OR OTHERWISE ARISING OUT OF THE EXHIBITOR'S PARTICIPATION IN THE REUNION EXPOSITION, INCLUDING SUCH INJURY OR DAMAGE OF ANY NATURE WHICH MAY RESULT, IN WHOLE OR PART, FROM THE NEGLIGENCE OF ANY OF THE EMPLOYEES OR AGENTS OF THE EXHIBITOR.

Each exhibitor will, if requested by Neighborly, furnish a certificate of comprehensive general liability insurance coverage, including protective and contractual liability coverage of \$200,000/\$500,000 for bodily injury and \$50,000 property damage, and Workmen's Compensation with Employer's Liability coverage of \$100,000.
9. Neighborly reserves the right to make such additional conditions, rules and regulations as Neighborly deems necessary to enhance the success of the exhibition.
10. Exhibitors agree to comply with all laws, ordinances, rules and regulations of Gaylord Rockies Resort & Convention Center.
11. No refunds will be given less than 90 days prior to event. All matters and questions not covered by these rules and regulations are subject to decision of Neighborly. Any request for exceptions should be made in writing.
