Bacteria: *Brevibacterium ammoniagenes*, *Enterococcus (Streptococcus) faecalis*, *Escherichia coli*, *Klebsiella (Enterobacter) aerogenes*, *Klebsiella pneumoniae*, *Listeria monocytogenes*, *Pseudomonas aeruginosa* PRD 10, *Salmonella (choleraesuis) enterica*, *Salmonella (schottmuelleri) enterica*, *Shigella dysenteriae*, *Staphylococcus aureus*, Methicillin resistant *Staphylococcus aureus* (MRSA), Vancomycin intermediate resistant *Staphylococcus aureus* (VISA), *Streptococcus pyogenes* (Clinical-Flesh Easting Strain, BIRD M3), and *Streptococcus salivarius*.

Fungi: This product is fungicidal against the pathogenic fungi, *Trichophyton mentagrophytes* (Athlete's Foot Fungus; a cause of ringworm). It will eliminate these fungi when used regularly to treat hard surfaces such as shower stalls. To treat mold and mildew repeat application at weekly intervals or when mildew growth appears.

DIRECTIONS FOR USE

DISINFECTION: Preclean the area to be treated by removing dirt, food particles, bodily fluids, grime, and dust. For best results, use B CLEAN with a sponge, cloth, mop, hand pump trigger sprayer, or low-pressure sprayer and apply to walls, floors, and other hard surfaces. **DO NOT DILUTE THE CONTENTS OF THIS BOTTLE.**

Thoroughly wet all surfaces. Allow treated surfaces to remain wet for 10 minutes, then allow to air dry or remove excess liquid with a damp sponge.

SANITATION: B CLEAN is designed for use in health care, food service, and manufacturing facilities, restrooms, offices, and homes. When used as directed this product is an effective sanitizer against *Escherichia coli* and *Staphylococcus aureus*. Remove all food and soil particles from areas or objects to be sanitized. Apply to these areas using a sponge, absorbent cloth, hand pump trigger sprayer, or fogging device. Areas should be visibly wet and allowed to air dry. If excess moisture is present after 10 minutes, remove with a damp sponge
